

## What is the Arkansas Opioid Recovery Partnership?

Arkansas received master settlement funding from the National Prescription Opiate Litigation. The settlement funding will be split evenly between Arkansas cities, counties, and the state. The cities (represented by the Arkansas Municipal League) and the counties (represented by Arkansas Association of Counties) came together to create the Arkansas Opioid Recovery Partnership to distribute settlement funds to opioid prevention, treatment, and recovery projects that will abate the opioid epidemic.

## What are the funding requirements?

The funding is meant to be start-up money for projects in opioid prevention, treatment, and recovery. The money is **not** meant to replace or supplant existing funding. Exhibit E, found at [www.arorp.org/funding-opportunities/](http://www.arorp.org/funding-opportunities/), specifies exactly how settlement funds must be used. The ARORP Advisory Board will use Exhibit E to evaluate your proposal.

## Should I hire a grant writer?

No, applications are designed to be user-friendly.

## What are the deadlines to apply?

The deadline for the coalition partnership empowerment proposal is March 15, 2023. None of the other proposal categories have deadlines.

## Is there a limit to the number of applications you can submit?

There is no limit to the amount of applications an organization can submit. The funding will be available for over a decade, so we encourage you to give each project the attention and focus it needs to be successful.

## Can multiple projects be funded in a single city or county?

Yes, multiple projects may be funded in a single city or county.

## What kinds of projects will be accepted?

There are several categories of proposals you can submit. The **general proposal** allows flexibility for you to submit any project related to opioid prevention, treatment, and/or recovery. We want you to assess your community's needs and submit a proposal to address existing gaps in services.

There are three other proposal categories: Naloxone Community Hero, Coalition Partnership Empowerment, and Overdose Response Team. Please note that naloxone provided through ARORP cannot be sold or provided to first responders or harm reduction groups. First responders may contact the University of Arkansas Criminal Justice Institute for training.

## **What happens if your application was funded and you cannot finish the proposed project?**

If you do not meet your proposed goals and objectives, funding will be recouped by ARORP.

## **How do you ask the mayor or county judge for a signature?**

Because ARORP settlement funds are owned by Arkansas cities and counties, you will need the mayor(s) and county judge(s) in your jurisdiction to sign off on your proposal. There are downloadable signature pages at [www.arorp.org/funding-opportunities/](http://www.arorp.org/funding-opportunities/). When approaching your mayor(s) or judge(s), we recommend that you request a meeting to provide a brief overview of your proposed project.

## **How detailed should your budget be?**

Plan to submit itemized quotes rather than rough estimations. If you have a line item for "staff training," for example, please break out the trainings you plan to attend as well as line items for each travel expense.

## **Is the application really this simple?**

The application is designed to be accessible. With that said, please take your time evaluating what you can accomplish well. Know that you will be held accountable for your proposal objectives. Once projects are funded, awardees cannot adjust their proposals or their funding amounts.
