Family Reunification

- 4 have less than 30 days recovery.
- 7 confirmed have sustained their recovery since leaving program.

Driver's License & Vehicle Ownership

- 12 have obtained their driver's license since entering NSRH or had driver's license upon entering program.
- 22 do not due to court order but are working towards achieving the right back.
- 4 have their own vehicles upon entering program.

Drug Tests

- 299 drug tests (16-panel) have been provided since 10/1/2023.

Services Provided

Next Step has expanded our drug and alcohol program into three phases. A unique combination of both clinical and non-clinical services, creating an atmosphere of a holistic approach to long term recovery. This three-tiered phase system is 10 months in length. However, residents are permitted to stay until they are ready to take their "Next Step".

We have partnered with Safe Haven Treatment to provide our clinical services.

Phase I - consists of 12 weeks of Intensive Outpatient Treatment (IOP). Upon completion, residents are eligible for weekend passes on the first and third weekend of each month.

Phase II - consists of 12 weeks of Outpatient (OP) drug and alcohol treatment with a reduced requirement of class time.

Phase III - is 4 months of aftercare, where participants maintain their progress.

Upon completing our ten-month program, we host a graduation where residents have family and friends celebrate their achievements with our staff and recovery community. They are also given the opportunity to continue living at Next Step as alumni; this is the truest form of peer recovery leadership.

In October, we received a generous donation of an \$80,000 RV, significantly expanding our capacity to accommodate 41 individuals.

Next Step Recovery Housing created a recovery podcast that has become a powerful avenue for shattering stigma surrounding addiction. Allowing the men to share personal stories of resilience, and the journey to recovery.

The podcast fosters understanding and empathy, providing a platform for individuals to discuss their struggles openly, dismantling stereotypes and misconceptions. Through candid conversations, listeners gain insight into the complexities of recovery, ultimately challenging societal judgments. The collective impact of these narratives can contribute to a more compassionate and informed community, breaking down barriers and encouraging a supportive environment for those on the path to healing.

We're presently under a construction project, incorporating an additional bedroom that will increase our bed capacity to 43.

We are diligently collaborating with the National Association of Recovery Residences (NARR) to formulate peer recovery training and conference courses. Simultaneously, efforts are underway in partnership with the Virginia Association of Recovery Residences (VARR) to secure Next Step Recovery Housing's accreditation through the NARR certification. Anticipated completion is targeted for February, with an extended deadline no later than March, reflecting our commitment to achieving these significant milestones in a timely manner.

Next Step is scheduled to deliver presentations at two prominent events: the National Reentry Conference 2024 in Nashville and the 2024 NARR Recovery Housing Conference in Virginia. The focus will be on elucidating the critical aspects of fostering successful recovery housing while strategically leveraging social media as a platform to enhance value and extend reach. This underscores our commitment to sharing insights and contributing to the advancement of best practices in the field.

In addition, we also faced an unforeseen situation in October, revealing inadequacies in our septic system. In our attempt to tie in our new container home into our main plumbing system the County's Department of Health mandated that we could not, as the existing system was designed for a single-family home, insufficient for the accommodation of 41 individuals, much less the addition of a container home which would increase that number. When we purchased the property, we did not foresee the septic system being inadequate, ultimately causing us to replace it. Consequently, we underwent an upgrade of the septic system, integrating additional lateral lines to align with regulatory compliance. This measure ensures adherence to health and safety regulations in our facilities. Our residence now has a stable and safe septic system that meets compliancy requirements and future growth of our facility.
