- 6 have maintained sobriety since leaving NSRH that we have been able to maintain contact with.

Driver's License & Vehicle Ownership

- 8 have obtained their driver's license since entering NSRH.
- 3 had a driver's license upon entering program.
- 4 have their own vehicles.
- 6 have their own homes upon exiting the program.

Drug Tests

- 146 drug tests (16-panel) have been provided since 04/01/2023.

Services Provided

Next Step has expanded our drug and alcohol program into three phases. A unique combination of both clinical and non-clinical services, creating an atmosphere of a holistic approach to long term recovery. This three-tiered phase system is 10 months in length. However, residents are permitted to stay until they are ready to take their "Next Step".

We have partnered with Safe Haven Treatment to provide our clinical services.

Phase I - consists of 12 weeks of Intensive Outpatient Treatment (IOP). Upon completion, residents are eligible for weekend passes on the first and third weekend of each month.

Phase II - consists of 12 weeks of Outpatient (OP) drug and alcohol treatment with a reduced requirement of class time.

Phase III - is 4 months of aftercare, where participants maintain their progress.

Upon completing our ten-month program, we host a graduation where residents have family and friends celebrate their achievements with our staff and recovery community. They are also given the opportunity to continue living at Next Step as alumni; this is the truest form of peer recovery leadership.

Next Step has had several opportunities to be presenting speaker on the topic of Recovery Housing in Arkansas and across the country including, 2023 Arkansas State Peer Conference, in Washington, DC at the 2023 SAMHSA conference. We are on the heels of our 2nd Annual Faith Recovery Conference which we are hosting musical guest and recovery advocate, Rare of Breed, on September 30th, 2023, and have multiple sponsors from ARORP partners, we have sold over 800 concert tickets, and 400 event tickets.

We are proud to announce that we were the recipient of a \$40,000 donated mini container home from Containing Luxury out of Florida that will increase our bed space for 2 more men. Next Step also received a donated passenger van from a Bentonville church and with the help ARORP partnership John 3:16 will be making all restorations and repairs.

Lastly, the men of Next Step have had several guests visit and tour our housing facility which include Special Agent in charge of the DEA members from both the House and Senate.
